I, _____ (owner as on reg papers), hereby agree to breed,
_____ Registration# _____ age, _____ color, _____ to the stallion **MWS Ima Flashyzipper**, AQHA number 3697292 in 200____, and to pay the sum of \$1000.00.

1. A booking fee of \$300.00 payable to mWs Quarter Horses is due when this contract is signed and returned. This fee is applied to the total breeding fee but is not refundable under condition no.11. The balance of the fee. \$700.00 plus all veterinary charges will be due and payable when the mare is picked up.

2. The mare shall be in a healthy and sound breeding condition and a veterinarian certificate of health shall accompany all mares. All mares will be required to have a negative culture when delivered to the ranch. Failure to furnish this certificate will be authorization to have the mare examined by a veterinarian at the mare owner's expense. The mare owner hereby gives permission to have the mare treated by a licensed veterinarian and have normal veterinarian services performed for anything which might insure the mares well being, including as many pregnancy examinations as deemed necessary by the veterinarian.

3. I agree to accept the responsibility for any veterinary expense incurred by my mare and foal. Such charges shall be paid whether or not the mare is settled. Veterinarian charges will be billed directly to the mare owner. Expenses will be billed at the end of each month and are due upon receipt of the statement.

4. All mares must have a negative coggins test within the last six months and must be vaccinated against Equine Viral Abortion (rhinopneumonitis).

5. The veterinarian agrees to diligently try to settle the mare. If, however, she does not settle, the stallion owner nor the attending veterinarian will be held responsible. I also understand that my mare will be bred by any method, which is believed best to the attending veterinarian.

6. If for any reason the mare is unable to be settled in a reasonable period of time, another mare may be substituted with the approval of the stallion owner.

7. I understand that the stallion owner, the attending veterinarian and **or** their agents, employees and assigns will not be held responsible for accident, sickness, or death to the mare and/or foal.

8. It is agreed that a live foal is guaranteed from this mating. Should the foal not stand and nurse, the mare owner shall be entitled to return privileges. This will apply only if the stallion owner is notified within one week from the foaling date. This date must be accompanied by a veterinarians statement. Under the foregoing circumstances and upon receipt of the specified notice, it is agreed:

a. Stallion owner shall give to the mare owner a free breeding to the stallion the following year only and to the same mare originally booked unless otherwise mutually agreed in writing between the mare owner and the stallion owner.

b. If the mare owner fails to deliver the mare (or substitute mare if mutually agreed as stated above) for rebreeding the following year, then any and all fees paid shall be forfeited; the right to rebreed is thereby canceled and stallion owner is released from any further obligation whatsoever.

c. If the mare dies or becomes unfit to breed then another mare may be substituted if approved by the stallion owner.

9. The owner of any mare who returns for a rebreeding must pay a chute fee of \$300.00. This fee must be paid when the mare is left for rebreeding (breeding).

10. It is further agreed that should the above named stallion die or become unfit for service, the fee will be returned if requested by the mare owner.

11. The Stallion Service Certificate will be issued only if the foal stands and nurses and same is reported to the stallion owner.

12. This agreement is subject to the provisions of IC 32-8-29-I (Liveryman's Lien), to additionally include breeding fee.

13. Limited shipped semen is available. A separate contract is required and where applicable is attached to and made part of this agreement.
